Preparation of the substrate:	 Substrate must be dry, clean, rough, stable and free of separating substances like oil, fats etc. The sealing must be applied within the revision time on a recently coated area stone carnet or synthetic resin serveds.

Application:	 The product is poured over the prepared area, applied with a rubber slider and spread evenly in a cross shaped pattern with a short or medium oiled roller. 	
	• In case of bigger areas care must be taken to work on in time in order to minimize overlapping traces and colour differences.	
Processing conditions:	 The material, air and ground temperature must be between 10 °C and 30 °C during the processing, installation and curing time. 	
	 The substrate temperature must be at least 3 °C above the dew point. 	
	• The air humidity should not be above 80 % at any time. The application should take place when temperature is at a constant or falling value to avoid blisters because of the extension of air inside the substrate. It is important to keep an eye on the ventilation during and after the application.
